- 1) Call to Order: President Heather Bender called the meeting to order at 7:00 pm.
- 2) Pledge of Allegiance

- 5) Approve January Accts. Payable & December Treasurer's Reports: An issue with statement from River Country Co-op (NAPA). Statement had a grand total of \$755.52, but the only invoice attached to statement was for a total of \$200.49. Board agrees that grand total should not be paid until the rest of the invoices are balanced against statement totals.
